### **1. The Junior League of Albany Rockwell Scholarship Award**

This \$1000 award is intended for a female resident of the capital district graduating high school in June 2012. Student must currently be involved in volunteer organizations or activities which serve the same or related focus areas as the Junior League of Albany's focus areas; AND must be able to demonstrate citizenship and initiative. ### **2. ZONTA International Young Woman in Public Affairs Award**

Young women, ages 16-19 are invited to apply for this award, which is based on leadership, community service, and essay content. Awards range from \$700-\$3000, and are to recognize young women who are committed to volunteer work, and dedicated to the advancement of the status of women. #### **4. Jean M Coon Humanitarian Award**

This award is open to juniors and seniors who have demonstrated humanitarianism in word and deed. This humanitarianism must be reflected in actual commitment of time and effort to community service, and through the individuals' description of community service in essays. Academic achievement is NOT a factor considered in this service award. Applications are available in guidance.

#### **5. Buick Achievers Scholarship**

This award is for high school seniors who plan to major in a course of study that focuses on Engineering/Technology or select Design and Business related programs of study; or demonstrate an interest in pursuing a career in the automotive or related industries using these areas of study. Academic achievement, community service, and financial need are criteria. 100 Achievers will win a scholarship of up to \$25,000 per year, for four years. #### **6. Phi Beta Kappa Scholarship**

#### **7. The Gene Robb Journalism Scholarship**

This award of \$1500 will be rewarded to a high school senior who plans on pursuing a career in journalism. Applicant must have a clearly demonstrated interest in journalism and provide samples of journalistic work. **8. The Ruth Goldstein Memorial Music Scholarship**
